MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this DAY, that is, Twenty-Second of December, Two Thousand and Twenty Two by and between

**THE FIRST PARTY** represented herein by its Principal Dr. Tushar Kanti Halder

**AND**

**Netaji Subhas Ashram Mahavidyalaya, Suisa, Purulia, West Bengal** represented herein by its Principal Dr. Haripriya Panda



## PURPOSE OF MoU

### In particular this MoU is intended to

1. Exchange faculty for organising seminars / symposia/ conferences in collaboration as and when required.
2. Exchange students of both institutes for add-on / certificate courses/ special classes.
3. Exchanges of cultural and other academic activities.

### NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETOAGREE AS FOLLOWS:

#### Clause1

1.A. Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

1.B. The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party by providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the First Party.

1.C. Both institutes may organize cultural activities in collaboration and provide suitable help and support to each other for the same; institutes may exchange their students also on this term.

#### Clause 2

### SCOPE OF THE MOU

2.A. Both parties believe that close co-operation between the two would be a benefit to the students of both institutes to enhance their skills and knowledge.

2.B. The Second Party will give the valuable inputs to the First Party in teaching / training methodology so that the students are ready for higher studies / job market.

2.C. Both the parties would organize seminars for the advancement of knowledge in select fields. In such cases the expenditure would be borne by the host party.

2.D. Select students of the First Party may avail themselves of any cultural events/ programmes to be offered by any party. In that case, participating students of either party would be provided accommodations, if needed, free of cost by the other party in their respective hostels.




**Clause 3**


3.A. The validity of the MoU is **five (5) years** from the date of agreement, that is Twenty-Second of December, Two Thousand and Twenty Two.

3.B. Both Parties may terminate this MoU upon 30 calender days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
