Sub: Extension of affiliation to Gobinda Prasad Mahavidyalaya, Bankura in the Under Graduate Courses in Education (G), Physical Education (G), Sanskrit (H) and Philosophy (H) with effect from the academic session 2019-2020.

Sir,

With reference to your proposal on the above subjects, I am directed to inform you that considering the resolution of the joint meeting held between Inspector of Colleges, Bankura University and the Officers of the West Bengal State Council of Higher Education on 05.03.2019 and on the basis of the recommendation of the Inspecting Team of this University, the Vice Chancellor has been pleased to grant extension of affiliation to Gobinda Prasad Mahavidyalaya, Bankura in the Under Graduate Courses in Education (G), Physical Education (G), Sanskrit (H) and Philosophy (H) with effect from the academic session 2019-2020 subject to fulfilment of the following terms and conditions laid down by the University below:

Intake to students for the courses offered:

Education (G)-40 Physical Education (G)- 20 Sanskrit (H)- 20 Philosophy (H)- 20

- 2. Representation of the college on different Boards, participation in the examination process shall be in accordance with the rules, procedure as prescribed by the University in this respect.
- 3. Fee structure of the Courses will be determined by the college in consultation with the
- 4. The college authority may engage 02(two) Guest Teachers each in Education (G), Physical Education (G), Sanskrit (H) and Philosophy (H) Department.
- 5. Adequate infrastructural facilities including a book grant to the tune of Rs. 50,000/- each be provided to Education (G), Physical Education (G) and a book grant to the tune of Rs. 1,00,000/- each be provided to Sanskrit (H) and Philosophy (H) department.
- 6. The Principal of the College shall have to take immediate steps to appoint teachers as specified above.

- 7. For holding the classes of the Course offered two rooms each of every subject shall have to be provided by the college.
- 8. The authority of the concerned colleges will make necessary arrangements from their own resources for providing instructional & infrastructural facilities including installation of fire fighting apparatus etc. in keeping with the requirement as per norms/ regulations/ guidelines etc. of the affiliating university and other regulatory bodies including the Government in the Higher Education Department presently in vogue and as will be amended from time to time.
- 9. Engagement of required number of faculty members and / or guest faculty is to arrange by the college concerned and the expenditure arising out of the exercise taken in this regard is to be borne by the college out of his own resources. Recommendations are made only on Non self-financing basis and no additional financial implication should come on H. E. Dept. because of this sanction.
